Minutes of the Coastal Catchment Meeting Held at Bradbury House, Market Street, Highbridge on Tuesday 02 May 2017 at 10.30 hrs Chairman Mr Jeff Fear

1	Attendance and Apologies: as per register appended. W Welland will arrive late – apologies received.	Action
2	Items additional to the agenda: IDB Governance arrangements	
3	Declarations of interest: D Watts – Alstone Lane	
4	Opportunity for the public to address the meeting: No members of the public present. The Chairman welcomed and introduced George Hellier, Trainee Technician to the meeting.	
5	Finance – overview of expenditure and budget : appended. The report identified two budget items for projects at East Brent which have been progressing in parallel. It was recommended that the Church Road project should be progressed as the preferred scheme and that the diversion proposal should not be taken forward at the present time although officers identified that there were other downstream works within the East Brent drainage system that will require improvements. It was agreed that Church Road was the preferred scheme and that funding for both schemes would be combined accordingly. Members accepted the report.	
6	Maintenance Programme: M S Wall (MSW) advised that J D Pope & Sons, R Duckett, B Perry and K Gordon had been invited to tender for Brents Rhyne extension works. Using a competitive tender procedure, in-line with the Board's Procurement Policy, the recommended contract award is to J D Pope & Sons with the lowest tender at £7,213.	
	Proposed D Tratt, Seconded R Shaw 'that in-line with the Axe Brue IDB Procurement Policy a contract for Brent Street culvert works to include ditch work, vegetation clearance and two	RES 1
	new culverts be awarded to J D Pope & Sons at a tender price of £7,213.' Vote: 4 For, 0 Against, 1 Abstain motion carried RESOLUTION 1	
	Desilting: Works undertaken from A360 to the railway line at Wick Lane. Following a competitive tender process, Spratt's Plant Hire Ltd, as the lowest tender was awarded the contract for desilting works to include bank repair where necessary. The work was undertaken to a satisfactory standard. Members were advised that a complaint had been received from a landowner however, due to incorrect information given to the complainant prior to submission, the complaint was later rescinded. Lympsham Rhyne Culvert: MSW proposed the inclusion in the works programme of a new culvert	
	to replace a deteriorated and poorly located culvert adjacent to Lympsham Rhyne. The culvert has an access gate and redundant water control structure. The structure is not on the Board's asset register and officers recommend re-siting a replacement structure 6m to 7m upstream on Middle Rhyne and to undertake bank repairs as necessary. Members agreed that the work could be placed on the	
10.45	programme for the year. hrs W Welland joined the meeting.	
	Desilting 2018: preliminary desilting sites assessment for works in 2017/18 include sections at BK01, Middle Lake Rhyne, Wick Rhyne, short section of New Rhyne connecting to Lympsham, Burnham Rhyne –from Pople's Bow to Edithmead Lane and Home Farm, West Huntspill Rhynes to connect with Mill Green works. MSW invited members with any comment or input of further sites to contact him. MSW will proceed to arrange silt surveys of the proposed sites. New Rhyne Lympsham proposed extension: handworks were undertaken by R Duckett in December 2016 for the protection of properties in Lympsham. The works have improved the conveyance of water through the system.	
	Investigation is now required for repairs of an unconsented culvert where subsidence is evident, and flows appear to be constrained. The culvert has been in place too long to undertake enforcement. Works to include headwall repairs. It was agreed that an indicative price is to be sought; estimated cost £3k.	RES 2
	Proposed D Tratt, Seconded R Keen 'that officers investigate and seek indicative costs for repair of an unconsented culvert with associated works as necessary.' Vote: unanimous RESOLUTION 2	
7	Improvements and capital works programme: 1. West Rhyne Improvements: modelling and investigation has been undertaken to understand hydrology of the catchment and the benefits of improvement works (slide presentation). The work could involve a series of culvert improvements to increase conveyance and reduce head losses allowing better discharge off tide. It was agreed that a project sub-committee would be convened for update and monitoring of investigations and surveys.	
	2. Church Road, East Brent: (Engineering Report 11.3.3 map ref S16) culvert works are being investigated for a scheme to be undertaken summer 2017. A grant in aid application has been

	the Axe Brue Board and the County highways team. Officers considered that improvement or mitigation works in the area were required before any further development should take place.	RES 4
