The Clerk further commented that, at this stage, this was only a Paper to propose potential Options that would need to be subsequently subject to further development requiring targeted resource before any formal proposal would be forwarded to the Axe Brue and Parrett IDBs as current members of the SDBC Consortium.

	4.5. The Clerk commented that he would require a formal response to the Paper from NSLIDB before expending any further Staff resource on developing any of the Options in further detail.
