A MESSAGE FROM THE CHAIRMAN, PETER MALTBY

During the year considerable progress has been made with drainage and flood risk matters in Somerset with the Drainage Board involved at every level. The work already done on the Rivers Parrett and Tone is proving its worth. We must not be complacent and know full well that the Somerset 20 year flood action plan has a long way to go. For the future there are four key elements that everyone needs to concentrate on.

Firstly – To work with all other drainage/flood risk bodies in Somerset to solve our problems.

Secondly – More dredging at priority sites indicated by our investigations. Thirdly – Improving the Sowy King Sedgemoor Drain system. This is underway with new culverts under the A372 at Beer Wall already in place and tilting weirs to be fitted this summer followed by widening etc. this autumn and next year. Fourthly – The Bridgwater Tidal Barrier between Bridgwater and Dunball, the initial investigation contract has now been let.

In addition, an enhanced maintenance programme has been completed in a number of areas that appears to be making a significant difference, particularly in the Penzoy system, Fivehead River, West Sedgemoor and North of Langport.

We are currently 2 years into a 20 year programme that will hopefully make our ratepayers feel more secure to carry on with their businesses and live without fear of flooding in their homes.

Finally, I should like to thank everyone involved with the Drainage Board for their hard work especially the staff who at all times and in all circumstances are polite and courteous.





PAWLETT HAMS WATER SUPPLY

The summer water supply to land in the northern part of the old Bridgwater and Pawlett area (land around Pawlett Hill) is fed via two pipes under the River Parrett from Cannington Brook which is on the south side of the River Parrett and was the old Cannington and Wembdon area.

During a series of spring tides in October 2015 a 100 metre long bank slip occurred to the south side tidal and river banks of the Parrett downstream of Stallingtons Clyce. This slip badly damaged both pipes over an approximate 70 metre length, so much so that the pipe is currently inoperable and will need to be replaced.

The Board is working with a civil engineering contractor, Crestmoor, to develop a repair solution to the damaged section however it will not be possible to have the pipe replaced by this summer's penn as the bank slip will need to be repaired before the pipe can be replaced. The Board is investigating options to see if it is possible to put a temporary solution in place as quickly as possible to provide penning this summer.

<u>RIVER PARRETT DREDGING</u> Following a competitive tendering process the Parrett IDB awarded WM

CHANNEL EXCAVATIONS The Environment Agency (EA) will shortly commence the final phase of the works at Beer Wall. This will involve excavating new channels to link the new culverts under the road to the Langacre Rhyne and the River Sowy.

This will generate a substantial quantity of excavated peat which will need to be removed from site. The EA would like to ask any landowner that is interested in receiving some of this material on their land or for other approved uses to make contact with them to discuss options, subject to necessary permissions being in place.

The Board will not usually grant Land Drainage Consent for services to cross watercourses

Where existing services do cross watercourses and the Board has chosen not to enforce the removal of the crossing the Board requires that all services are marked as shown in figure 1 above

Marking service locations in this way will help reduce the risk of damage or loss caused by the Board's contractors while carrying out channel maintenance

The service owner should check the maker post annually and renew or re-paint as necessary.

The Board or its contractors will not be held responsible for damage to any services that are not clearly marked or have not been consented

MINEHEAD WORKS

The Parrett Drainage Board has been working to reinstate rhynes and attenuation ponds in Minehead after years of no maintenance. The watercourses and ponds, off Seaward Way in the town, have not been maintained for a number of years, partly due to limited funds. Given the importance of maintenance in reducing flood risk an agreement was reached between West Somerset Council and the Drainage Board to

joint fund the work. In the autumn pioneering work was undertaken to part clear years of reed growth from two large flood attenuation ponds. Over the winter further work was completed to clear adjoining rhynes, by hand, due to there being no machine access due to development encroachment in the maintenance strips. Future years work under the same joint funding agreement will see the condition of these vital drainage channels and ponds improve further and hopefully facilitate improved access.

PROSECUTION

It is an offence, punishable by a fine of up to £5,000, if any person without the consent of the Parrett Internal Drainage Board, interferes with any sluice, or other water control or structure or appliance for controlling or regulating the flow of water in, into or out of a watercourse (Section 66(6) Land Drainage Act 1991). Neither the Axe Brue nor Parrett IDB's will tolerate tampering with Board sluices or structures.

ANNUAL CHANNEL CLEANING

This year the Board will maintain approx. 571.000m (355 miles) of watercourse as part of the annual cleaning programme.
