6. Confirm that I will notify the Board of any future changes in the information given in this application which might be material to the continuation of this consent.
7. Confirm that all the information given in this application, and any questions which the Board may have about it is, and will be, true to the best of my knowledge and belief.
8. Undertake to submit a full and accurate application, and accept that the period of two months specified in the Land Drainage Act 1991 for deciding the issue will not begin to run until the Board is satisfied that it has all necessary information.
9. Undertake to reimburse the Board for the cost of any Engineer's or other consultant's fees incurred by them in the consideration of this application.
10. Enclose the application fee of £50.00 per structure. (Please make cheque payable to Somerset Drainage Boards Consortium)
